answer. Just as often, Beck refused again. The committee backed up checks and other documents its stand that Beck never started putting money back into the union until after the Internal Revenue Service went after him in March 1954. That chapter opened up when Sen. Ives (R-N.Y.) asked Beck if he was engaged in collective bargaining. Beck said it depended on circumstances. He volunteered that he and the teamsters authorized a \$1 million dollar loan to the Fruehauf Trailer Corp., which was repaid 14 months later. But he said that in other instances been judgment would dictate against a loan. Committee counsel Robert F. Kennedy took that opening and asked whether Beck had ever received any money directly or indirectly from Fruehauf. Beck took the Fifth Amendment.

Beck did it again when Kennedy asked whether he found himself in trouble with the income tax people in March 1954 because he had taken \$200,000 from the union in the past. He asked whether the witness went to Fruehauf, got \$200,000 and gave it to the union the following August. Money Arrangement. The committee counsel inquired whether it was true Fruehauf didn't have that much money but arranged for Beck to get it from Brown Equipment Co., a trucking firm, which issued four checks for \$50,000 apiece. He produced what he said were photographic copies of the checks.

Tax Drop Postponed; Blast Kills Mexicans

WASHINGTON, March 27 (AP)—The Senate today passed a bill to postpone until next year scheduled three-billion-dollar annual drop in business taxes. It did this after refusing to write in special relief for small business. A voice vote sent the measure to the House, which had passed somewhat different version earlier.
