### 9 Hurt In Wreck

NEWTOWN, Conn. (P)—A school bus carrying 37 high school seniors and three adults to an outing at West Point, N. Y., skidded and turned on its side today on a steep, rain-swept hill. At least nine were injured.

### Flash Flooding

OKLAHOMA CITY (P)—Cloud-burst rains fell in south-central Oklahoma early today, causing flooding in some areas. Lindsay, 50 miles south of Oklahoma City, reported 6.30 inches of rain.

### 4 Die In Blast

MARSEILLE, France (P)—An underwater mine exploded in the harbor of France's No. 1 port around noon today, wrecking a Dutch dredge which was trying to lift it to the surface. Four crewmen of the dredge disappeared and are thought to have been killed.

CHICAGO (P)—A 38-year-old woman, fatigued because she's been getting only four hours sleep a night, plans to slumber for five days straight next week.

Impossible? Not under the power of hypnosis, believes Mrs. Fred A. Dust of nearby East Chicago, Ind., a switchboard operator and widowed mother of two.

She talked the Hypnosis Institute of Chicago into supervising the Monday-to-Saturday "hypnotic hibernation" so she can catch up "on all my lost bed time."

The institute hopes to gain some new scientific facts about sleep and relaxation as a result of the marathon nap.

Mrs. Dust came to the institute with the suggestion after her doctor advised her to take a long rest because of nervousness and restlessness.

Since she had only five days vacation coming, she figured hypnosis would be an excellent way to cram a lot of sleep into a short time.

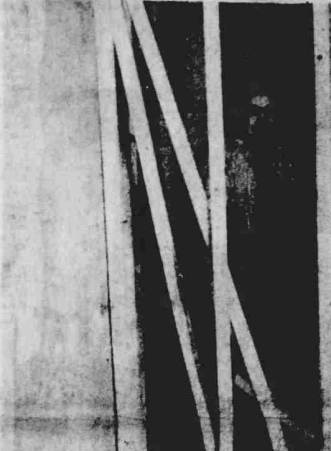
**FULL PROGRAM**

## 'Suspecting Mind' 2nd Degree Verdict Asked For Grimes

WASHINGTON, N. C. (P)—Solicitor Walter Cohnon argued today a Beaufort County Superior Court jury today that J. D. Grimes Jr. was guilty of second degree murder in the slaying of Haywood Paul.

Cohnon contended that Grimes was "in a suspicious mind" when he found his wife and Paul, 47-year-old farmer, lying together, half unclothed, under a tobacco barn shelter.

Cohnon said the element of suspicion made the slaying second degree murder.

If Grimes, as he has testified, did not suspect anything, Cohnon said the verdict should be manslaughter.

The jury is expected to receive the case this afternoon after final arguments and the charge by Judge Joseph W. Parker.

Leroy Scott, a defense attorney, told the jury this morning Grimes should not be punished for the killing because "he suffered the tortures of a thousand hells all ready."

**NO EFFORT**

# Truck Leaves Bridge, Kills Two Fishermen

## Driver Seriously Hurt In Thirty-Foot Plunge

VALDESE — A truck loaded with stone hurtled from Castle Bridge at the Catawba River between Burke and Caldwell counties this morning, killing a man and his wife fishing below.

The truck driver was injured seriously.

Bill Miller, operator of Sossom Funeral Home in Valdese, identified the dead couple as Mr. and Mrs. Frank Bryant, 225 Mill

St. Lenoir.

Miller, who said he answered an ambulance call about 9 a.m., said he rescued the truck driver, identified as Robert Dellinger of Valdese, from the crushed cab of the truck.

Miller quoted Dellinger as saying he was approaching the bridge from the Burke County side when his brakes failed and he swerved off the right side of the bridge.

Observers fishing along the rocky bank said the truck hit Mr. and Mrs. Bryant as they stood fishing. Their nine-year-old son Steve was standing 20 feet from his parents, they said.

**BOAT USED**

Miller said he used a fisherman's boat to rescue Dellinger from the water. The boat was used to reach the truck, which was stuck in the water.

**RAIL TORN AWAY**

About 80 feet of wood railing was torn away as the truck fell 30 feet from the bridge to the river's edge, Miller estimated.

Driver Dellinger was rushed to Valdese General Hospital with head and chest wounds and other injuries. His condition was described as critical.

The bodies of the couple were taken to the Sossom Funeral Home and will be taken to the Lenoir Funeral Home in Lenoir sometime today.

The Valdese Rescue Squad assisted in dragging the truck from the water and finding Mr. Bryant's body, Miller reported.

The ambulance driver reported the wheels' springs were torn from the vehicle. He admitted the truck traveled 210 feet after it left the bridge.

**TOOK A WHILE**

Guardsmen Leave Little Rock's Central High School After Gov. Faubus Ordered Them Out

## Ike Calls Guard Withdrawal 'Step In Right Direction'

LITTLE ROCK, Ark. (P)—Gov. Orval Faubus withdrew the National Guard from Central High School last night and President Eisenhower today called it a necessary step in the right direction.

Faubus' action came shortly after issuance of a federal injunction commanding him to cease using troops to block school integration. His attorneys immediately began exploring avenues of legal appeal.

"As long as this order is in effect and until its certain reversal on appeal, I will comply," Faubus said.

**THE STATEMENT**

Eisenhower, commenting at Newport, R. I., on the development in the Little Rock integration case, said:

"The action by the governor of Arkansas in withdrawing the detachment of Arkansas National Guard from the Little Rock school is a necessary step in the right direction."

"I am confident that the citizens of the city of Little Rock and the State of Arkansas will welcome this opportunity to demonstrate that in their city and in their state proper orders of a United States court will be executed promptly and without disorder."

Rep. Brooks Hays (D-Ark.), who arranged last Saturday's Newport meeting between Eisenhower and Faubus, was en route to Little Rock from Oklahoma City to appraise the situation and report to the President.

## Board's Decision Schools Will Be 'Open To All'

LITTLE ROCK, Ark. (P)—"Schools will be open to all children Monday," Little Rock schools Supt. Virgil Blossom said after a meeting of the Little Rock school board this morning.

He said all adults, including newsmen and photographers, will be asked to stay outside the school building when classes are resumed after the weekend holiday.

Events that transpire inside the building if Negro students enter will be relayed to newsmen about an hour later by school officials, Blossom said.

A Little Rock police official who asked not to be identified, said police will be posted at Central High Monday but exact strategy has not been worked out.

**NOT KNOWN**

Whether the nine Negro students who were turned away by troops Sept. 4 would try to enter Monday was not known.

"I don't know and I don't think the others have decided," said Thelma Motherhead, one of the students.

Mrs. L. C. Bates, head of the Arkansas branch of the NAACP, said she had no information of the matter yet.

Little Rock residents anxiously awaited Faubus' next move and looked to Monday morning.

Arthur J. Bickett of Little Rock, one of the outspoken segregationists in the white crowd that gathered almost every day recently in front of Central High, was asked today if there were plans for a demonstration at the school.

"We have always been guaranteed the right to peacefully assemble," Bickett said. "I know of some school parents who are going to be there. I don't know that a peaceful boycott of anything like that."

MIAMI BEACH, Fla. (P)—President James Beck of the Teamsters Union and James R. Hoffa, the man who wants to succeed him, refused today to appear before the AFL-CIO Executive Council in New York Tuesday to answer charges of improper conduct.
