Word For Our City Manager: 'A Professional'

What kind of man has the City Council hired to run Charlotte's vast and complex city government? "A real professional, strictly a pro," says a Florida friend.

The News asked both Veeder's friends and his political enemies the question today. The answers all included the word "professional."

"We've disagreed," said one Ft. Lauderdale man, "but he is a pro. Bill can get the job done. He has vision, drive, determination, dedication. He is a slave to good municipal administration."

It is not hard to find out about Bill Veeder from people in Ft. Lauderdale. And most of them point out the same attributes:

He has an orderly, crisp, brilliant mind. He knows personnel. He has vision, drive, determination, dedication. He is a slave to good municipal administration."

OTHER SIDE

To those who have opposed him or disagreed with him, he appears to be hard-headed, inaccessible, too progressive.

He runs a city according to reports, like a large corporation. He is the leader, the chief. He makes the policy and he delegates duties to department heads. He does not waste time, his friends say, with petty things.

"Bill is going to work 24 hours a day for Charlotte, but he's not a workaholic. His time averaging complaints about garbage collections," one said.

Department heads trust him. He trusts department heads.

"He is an organizer and he knows his personnel. Once he gets the right man for the job, he's satisfied. That man runs his department until Veeder sees a weakness. Then he'll go," another man said.

Too much, Ft. Lauderdale people say, has been made of Veeder's troubles in that city with some members of the local government.

WRONG CAMP

"It is simpler to pick the wrong people to support," a newspaper editor said. "He got into discussions in a political campaign because he wanted the people he considered best for the city on the City Commission. They lost. He had his hands slapped — and landed on 90-day probation."

Pilot Fined After Jet's Long Dive

NEW YORK (U-P)—The pilot of the jet airplane that took a near-fatal 30,000 foot dive toward the Atlantic last February has been fined \$1,000 by the Federal Aviation Agency for being out of the cockpit at the time.

Pan American Airways, the owner of the plane, was also fined \$1,000 for failing to keep a flight-recording device in operation on the new 707 Boeing jet.

The copilot, who was at the controls when the plane suddenly dived from 35,000 feet, was notified of the government plans to suspend his captain's rating for six months. The reason for the suspension apparently was his failure to stop the dive immediately.

The jet, with 114 passengers, was flying from London to Gander, Nfld. Feb. 3, when it suddenly nosed down. The pilot, Capt. W. Waldo Lynch, was in the passenger compartment. Because of the tremendous speed and angle of dive he had to fight his way back to the cockpit.

He and the copilot, Capt. S. T. Peters, leveled the plane with difficulty a mile in distance but only a few seconds in time from almost certain death in the ocean.

Laundries Are Not Exempt

RALEIGH (U-P)—Senators drew a tight defensive ring around the state's minimum wage law today, and killed an attempt to amend it.

With only one dissenting vote, members of the Senate manufacturing, labor and commerce committee defeated a bill which would have exempted laundry workers until 1963. The minimum wage law, enacted several weeks ago, went into effect next Jan. 1. It will require the workers covered by the act to receive at least 75 cents an hour.

Are County Car Privileges Being Abused?

The county can't be sure county-owned cars are being driven on casual personal errands, but nobody could get by with taking a long trip in one.

That pretty well sums up the system the county government has for controlling personal use of county cars by county employees.

High L. Farr, superintendent of the county garage, said today he does not think county employees are using county cars for personal use. Otherwise, he feels, he would know about it.

A private citizen told County Commissioners yesterday he had seen several county cars on the roads at night and on weekends when county employees normally are off duty.

ODD HOURS

The board expressed interest in the matter but explained many county employees are on duty at odd hours.

authorized for 24-hour-a-day duty—in other words they are taken home by county employees at night and on weekends when county employees normally are off duty.

These 30 cars are being used by employees who must do part of or all of their work before or after county hours (8:15 a.m. to 5:15 p.m. Monday through Friday).

Court Rulings Get Applause

WASHINGTON (U-P)—The Supreme Court's newest decisions on state election laws and congressional investigations drew applause today from some past critics in Congress.

Sen. Strom Thurmond (D-SC) was pleased by what he called "the apparent change in the attitude of the court."

"I hope this trend continues and they return to respecting the rights of the constitution, states and society," Thurmond told a reporter.

Chairman Francis E. Walter (D-Pa.) of the House Committee on Un-American Activities commented that he had believed all along that past decisions of the court were being misconstrued, but the strike scene was orderly.

In two 5-4 rulings yesterday, the court said state election laws may be invoked to protect the state, and the Congressional committees have a right to question educators as well as others about alleged Communist activity.

Whether these actually represent any alteration in the court's attitude — as Thurmond indicated he felt they did — is one for lawyers to debate.

Justice Clark, who wrote the majority opinion in the case touching on state election laws, went to some pains to say the court had not stripped the states of the right to protect themselves when it upheld in 1956 the conviction of Steve Nelson, a Communist leader, under Pennsylvania election laws.

There was a widespread view after the 1956 decision that the court had pulled the teeth of state election laws. Clark was saying in effect that this was a misunderstanding.

Pickets Parade

All Remains Quiet Along Mill Front

HENDERSON—Air National Guardsmen from Charlotte pulled their first full day of strike duty Monday but they encountered no violence.

The shift change at the mills went without incident this morning.

The Guardsmen stood watch at the Harriet-Henderson Cotton Mills gates during changes at 7 a.m., 3 p.m. and 11 p.m.

They were back at the gates again at 7 a.m. today.

Eight pickets, the maximum number allowed under a court order, patrolled the mills yesterday, but the strike scene was orderly.

Guardsmen confined to the National Guard Armory here yesterday watched a caravan of about 20 automobiles circle the armory. The occupants of the cars waved American flags and blew car horns to celebrate the release of Luther Jackson from jail.

5-DAY TERM

Jackson had been in jail five days on charges growing out of strike violence here.

Meanwhile, Vance County Commissioners have agreed to reconsider their refusal to provide money for extra officers to relieve the Guardsmen pulling strike duty.

Gov. Hodges asked both the city and county two weeks ago to appropriate funds to hire additional officers to relieve at least part of the Guardsmen.

Poison Feared As Cause

A Charlotte woman died mysteriously early today and her husband was in critical condition at Memorial Hospital early this afternoon.

Mrs. Edna Davis, 32, 909 N. Pine St., died shortly before 3 a.m. at Memorial Hospital.

Police said the cause of Mrs. Davis' death isn't immediately known, but they believe she died from some type of poisoning.

A physician told Detectives Cal Ramsey and Jack Fesperman that Walter Davis, the woman's husband, is in critical condition at the hospital.

The doctor said it looks like Davis is suffering from some type of poisoning.

Coroner Dr. W. M. Summer-ville was to perform an autopsy on Mrs. Davis' body some time this afternoon.

The Davis couple lived in an old two-story rooming house at 909 N. Pine St. The house is operated by Arthur Drake, 73.

Health Officers Tom Bevin and M. J. Dallas went to the rooming house this morning and took samples of the food in the kitchen to run tests on it.

TABLET FOUND

Bevin said a reach poison tablet was found on the kitchen table.

Ramsey said Mr. Davis' body is covered with blue marks, a sign of poisoning.

Nathan Long, who rooms in the house, he heard Mrs. Davis scream out this morning around 4:30 o'clock.

"I was in the room what was wrong," Long said, "and she said she was sick and couldn't get her breath."

He and his husband got it bad. They were both friends of mine. Good friends."

Mrs. Davis died shortly after a Hankins-Whittington ambulance got her to Memorial Hospital.

The ambulance driver told police he smelled a strong odor of alcohol in the Davis bedroom when he answered the call.

Mr. Davis became ill around 3:30 this morning, police said.

James Whittington was at the home to make the funeral arrangements for Mrs. Davis when Davis was found dead.

Whittington took Davis to the hospital.

About six people live in the house and none is employed at this time.

Drake told police all of the residents have access to the kitchen.

WINE DISCOVERED

Pine found a glass of wine in the kitchen. There were very few glasses in the house.

A jar of honey was found in the kitchen cabinet.

"I make cough syrup out of that," Drake said, "by mixing it with paragonic."

Drake said Davis drank nearly a quart of milk and ate a pack of peanut butter crackers this morning.

That's all I know he had to eat," he said.

The Davis couple had been living at the house for about three weeks.

Funeral arrangements for Mrs. Davis are incomplete.

Mrs. Davis, the former Edna Davis, was the daughter of Mrs. Mary Satterfield of Charlotte and Edward Clark of Rock Hill, S. C. She was born June 22, 1926, and was reared and educated in Charlotte.

Mrs. Davis is survived by her husband; her parents; a sister, Mrs. Don E. Haley of Charlotte; and a number of half-sisters and half-brothers.
